County Commissioner's Report

It gives me great pleasure to report that Scouting in Birmingham is a truly vibrant and thriving organisation, and that 2016 has been an incredibly successful year in which we've continued to take forwards and demonstrate real progress toward our strategic objectives.

Whilst we've continued to dedicate a significant effort on the four individual objectives that comprise our national 2018 vision (Growth, Inclusivity, Youth Shaped and Community Impact), I want to focus on two specific areas within this annual report; our growth story and the development of youth shaped Scouting within Birmingham.

From a growth perspective, the 2017 annual census shows a net increase of 10% in our total membership, with the County now reporting 7,462 young people and adults which represents a terrific increase of more than 28% and an additional 1,592 people having joined Scouting in Birmingham over the last 5 years. Our national focus on recruiting additional leaders to help us provide Scouting to over 54,000 young people who are on waiting lists is equally valid in Birmingham and even though we have 2,000 adult volunteers within the County we know that if we can recruit additional leaders it will enable us to reach even more young people.

We reported last year that we had appointed Sean Kelly and Jamie Burrell as our new County Youth Commissioner and Deputy County Youth Commissioner and I'm delighted to be able to report that we now have District Youth Commissioners in place across four of our six Districts and they're playing an active role in helping our young people shape their Scouting experiences and ensure they have a voice within their sections, Groups and Districts to advise and influence what's happening on a day to day basis. As we move into 2017 the Youth Commissioner Team have great plans to support the national #youshape month in February and are planning local forums and a County-wide young leaders weekend.

2016 was definitely a year for celebrating as we saw a Beavers 30th Birthday Party, the Cub 100 celebrations and our own

BrumJam international camp. Over 2,000 people took part in these events and had an absolutely awesome experience – it was a delight to be able to attend these great activities and I'm sure that they've made a real difference to many of our members. Alongside these 'one-off' events, we hosted the National Scout & Guide Symphony Orchestra again last July where over 110 young people enjoyed a fabulous week of tuition and activities that led to a number of spectacular concerts being performed at the end of the week. The County Team have also continued to support the Groups and Districts within Birmingham, with an excellent programme of activities which continue to events such as our Bivouac, BrumVenture and iceScout weekends, Mountain Leadership Training, Faiths for Fun, our County Remembrance Service and a wide range of sectional competitions including Air Rifle Shooting, Football and Chess.

One of the most memorable occasions of 2016 was the unveiling of the National Scout Memorial at the National Arboretum in Staffordshire which was the culmination of the The Scout Memorial Project. The team raised in excess of £140,000 to fund the construction of what is a truly poignant memorial to everybody who has given service to Scouting and their communities. Over 1,500 attended the unveiling including Wayne Bulpitt, the UK Chief Commissioner, and a number of other special guests. This really was a moment to be supremely proud of our County and the young people who originally inspired the project.

We've continued to see many of our young people achieve Chief Scouts Awards, with over 420 awards being earned during the year by Beavers, Cubs, Scouts and Explorers as well as a number of Queen's Scout Awards and two Explorer Belt Expeditions which took place in Austria and Canada during the year. We held our 3rd Celebration & Achievement Evening at the Pathfinder Lodge in Northfield just a few weeks ago where we celebrated the higher awards. These awards are not easily earned and I'd like to thank all of our leaders who support and encourage our young people in achieving them.

From an administrative perspective, the County continues to be financially stable and I'm delighted to report strong financial performance with a small operating surplus of £2,380 being generated during the year. These figures include the proceeds from the County Shop but exclude donations that we've received. Our accounts show a net £122,220 inflow of funds which includes donations and income received for events where the costs will be incurred in 2017). Our activity centres run by Blackwell Adventure have also reported a great year with a turnover of £937,418 and a net surplus of £37,685 being generated.

The County Management Team and our Programme Teams have continued to meet throughout the year, helping to shape our future plans and priorities.

I hope you'll agree that 2016 has been an excellent year for Scouting in Birmingham and I believe we have strong foundations in place to build upon even further as we go into the future, however none of this would be possible without our remarkable team of leaders, supporter and parents across the County and my sincere thanks go to everybody for their continued energy and enthusiasm, providing great experiences for all of our young people.

County Centres – Blackwell Court and Pikes Pool

2016 has been extremely busy for Blackwell Adventure and we were pleased to play our part in hosting the celebrations for Cubs 100, Beavers 30 and, of course, BrumJam.

The Centre continues to be popular with Schools and Colleges with both the manor house and tented villages proving in high demand.

As part of the continuing programme of improvements the main boy's toilet block at Blackwell Court has been completely refurbished and we are now undertaking a similar schedule of improvements to the main girl's toilet block. In addition, a new fan descender has been added to the range of adventurous activities.

In looking forward the Board wish to continue with its plans to provide a new accommodation block to house up to 80 young people. Architects have now produced a detailed set of plans and supporting documentation. The next stage is to seek outline planning permission from Bromsgrove District Council.

During the year, the centre saw the departure of Paul Barlow, the Campsite and Facilities Manager after eight years' loyal service. The year has also seen several changes in Board membership who have spent a significant amount of time reviewing the governance arrangements for the company and the overall working relationships with the County.

Once again, our thanks go to all those who 'made it happen' during 2016 especially our paid staff and our dedicated volunteer team whose skill and expertise consistently 'deliver the goods'.
