- c. I am not disqualified from being a Company Director; and
- d. I have not failed to make payments under County Court Administration Orders; and
- e. I have not at any time been removed by the Charity Commission or by the court in England or Wales from being a Trustee due to misconduct; and
- f. As a trustee of a children's charity, I agree to the Scout Association carrying out checks into my suitability to carry out a role in Scouting, including obtaining references and criminal records checks
- g. I am capable of managing and administering my own affairs; and
- h. I am aged 18 or over

From January 2016, all adults on Executive Committees (at Group, District, County/Area and Region level) will be required to become members or associate members of the Scout Association.
